COURSE DETAILS

1. Clothing and footwear, Please wear work clothes suitable for this type of environment. Long sleeve garments and leather shoes are essential. We provide leather gauntlets and a protective overcoats, we also supply your welding helmet.
2. The duration of your course depends on which course you have chosen and your ability. The Taster course usually lasts between 1-2hrs with the other courses lasting longer sometimes between half and a full day. It really depends on how your course goes and how quickly you begin to develop your new skills. PLEASE MAKE SURE YOU ARRIVE 10 MINUTES BEFORE YOUR START TIME.
3. Directions. Ferrers Centre Courtyard Workshops & Artists. The Ferrers Centre for Arts and Crafts is situated on the Leicestershire / Derbyshire border between Ashby de la Zouch and Melbourne off the B587. Our postcode for Sat Navs is LE65 1RU but we are finding that some do better with LE65 1RW. The Ferrers Centre for Arts and Crafts is sign posted with brown tourist signs from all directions (look for the anvil symbol). Parking is in the Estate Car Park – charges apply at weekends and Bank Holidays only. Charges are £1.00 for 1 hours and £2.00 for 2 hours or more; parking remains free of charge in the week. Limited disabled parking is available directly opposite the centre, with good access to the studios and tea rooms.
